To whom it may concern,

This letter is in response to your request for information on the BASF product listed above.

EU Directive 2015/863 Restriction on the use of certain Hazardous Substances (RoHS):

Based on the information available to us from our raw material suppliers, and our knowledge of the products' compositions, the BASF product listed above does not contain any intentionally added cadmium, hexavalent chromium, lead, mercury, polybrominated biphenyls (PBBs), polybrominated diphenyl ethers (PBDEs), Decabromo diphenyl ethers (Deca-BDEs), Di (2-ethylhexyl) phthalate (DEHP), Butyl benzyl phthalate (BBP), Dibutyl phthalate (DBP) and diisobutyl phthalate (DIBP). BASF does not routinely analyze these products or the raw materials for the presence of these substances. However, based upon knowledge of the manufacturing process and the raw materials utilized, these substances are not expected to be present in the final products in levels exceeding the limitations of EU Directive 2015/863 listed below:
