

Celanese Engineered Materials - Information on REACH Status

Status of Information for February 4th, 2026

Products covered by this statement are listed in the annex.

Celanese is aware of the obligations imposed by REACH on EU manufacturers and importers as well as on downstream users (Registration, Evaluation, Authorization and Restriction of Chemicals, 1907/2006/EC).

We comply with the requirements of the REACH regulation with regards to our products sold in the EU, raw materials used in our European facilities, our own product imports as well as our obligations as a downstream user in the European chemical industry.

The products marketed by Celanese Engineered Materials are not directly subject to the registration requirements under REACH, as polymers are excluded from registration obligations. For products imported into the EU by Celanese and where relevant, monomers and polymer additives were successfully registered under REACH.

Substances of Very High Concern (SVHCs)

Substances of Very High Concern (SVHC), as identified according to Article 59 (1) of Regulation (EC) No 1907/2006, are not intentionally added to the products listed on the annex to this letter.

Based on the available information from our raw material suppliers, we are not aware that SVHC are contained in the listed Celanese products at or above 0.1% w/w.

These substances are not part of our routine analytical procedures and quality control system. Therefore, analytical data on these components cannot be provided.

If an SVHC contained in a specific product exceeds the concentration limit given in the REACH regulation, article 31(3), this information needs to be stated on the European Safety Data Sheet (SDS).

Substances listed in Annex XIV of REACH (List of Substances Subject to Authorization) were previously identified as SVHC.
